Commander's Comments

Recipes for a Clean Boat

Nothing beats a clean boat. We boaters spend a lot of time and elbow grease keeping our boats clean. Many manufacturers of boat cleansing products have gone "green" with a reduced impact on the environment. They use various qualifications that often don't mean much. Here are a few:

Biodegradable – According to US Federal Trade Commission voluntary guidelines this means that a product or its packaging degrades and returns to nature in a "reasonable period of time," given the location it is normally disposed in. A garbage bag marketed as "degradable," with no other qualifications is deceptive. It will only decompose naturally in soil burial and in the presence of water and oxygen. If the bag is disposed through incineration or placed in a landfill with little moisture and oxygen degradation will take a lot longer.

Compostable – A manufacturer can make an unqualified claim that its packaging is compostable. In municipal composting facilities this may work but the packaging will not break down into usable compost in a home compost pile or device.

Recyclable – Nationally marketed Plastic containers with the numbered recycle logo on the bottom constitutes a recyclability claim. But recycling facilities for these containers are available only in a small number of communities.

Read the labels on all products you use on your boat, realizing that manufacturers are not always required to list every ingredient in a product or provide qualifiers for recyclability claims they make.

Here are a few timelines for a few common products to bio degrade:

ITEM	TIME TO DEGRADE
Cotton rags	1-5 months
Paper	2-5 months
rope	3-14 months
Orange peels	6 months
Wool socks	1-5 years
Cigarette filters	1-12 years
Tetrapacks	5 years
Leather shoes	25-40 years
Nylon fabric	30-40 years
Plastic bags	10-20 years
Plastic 6-pack holder rings	450 years
Styrofoam cup	1-100 years

Free Recreational Vessel Courtesy Checks

If you are interested in doing Recreational Vessel Courtesy Checks (RVCC), please read on.

Transport Canada has asked the Canadian Power & Sail Squadron (CPS) organisation to raise awareness of boating safety issues and increase the number of pleasure craft operators following safe boating practices. CPS volunteers completed about 1,000 Recreational Vessel Courtesy Checks in 2009 and CPS is looking forward to surpassing that number for 2010. 600 courtesy checks were completed in Ontario alone.



In a nutshell, here is what a CPS Boating Safety Specialist does; referencing the appropriate section in the "Safe Boating Guide" (determined by the vessel length) the volunteer goes through the list of minimum safety equipment required to be on board as set by Transport Canada and using a Transport Canada form, checks off the safety equipment on board and if everything is there the CPS Boating Safety Specialist issues the boat owner a 2010 RVCC decal. Since boating laws have changed and fines are heavy we are assisting the boating community to keep them legal and providing them knowledge to boat safely. This knowledge will save the boater from getting a possible fine from the OPP and will enhance their pleasure boating experience.

I did many courtesy checks in 2009 and found that visiting with different boaters to be lots of fun and a very rewarding experience. I was amazed at some of the myths that boaters had about the safety equipment they were required to have on board. On February 25th, 2010 the following eight CPS members attended my 1st Boating Safety Specialist training session. A big thank you goes to these brave folks (remember, it was my 1st training session) who withstood a very easy paced 3 hour training session and passed with flying colours.

If you prefer, we can also fax or email you a copy of the application. Just call our office at 1-800-268-2628.

Once you receive your quote and it is acceptable, you can provide us with the hull serial # and effective date. We will then issue the policy.
